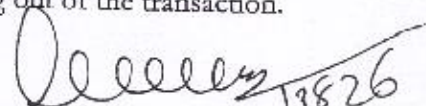
PUBLIC AUCTION NOTICE

General Terms & Conditions:

1. Maruti Suzuki Swift Dzire bearing registration nos. KA04MP4057 can be inspected at the ICAR-NBAIR, Hebbal premises from 24.08.2026 to 25.08.2026 between 10.00 am and 11.00 am.
2. An EMD amount of Rs. 10000/- (Rupees ten thousand only) (refundable to unsuccessful bidder) (will be adjusted in the bid amount of successful bidder) shall be deposited in cash before the commencement of auction time on 31.08.2026. Bidders without remitting EMD shall not be allowed for the bidding process. Only one bidder against one EMD shall be allowed to participate in the auction process.
3. 50% of the bidding amount shall be deposited by the successful bidder on the spot, and remaining 50% amount (including EMD) should be deposited at the time taking over the vehicles. The vehicles shall be handed over only after getting the ownership of vehicles changed at RTO at the cost and time of successful bidder.
4. All the RTO fees for getting the vehicles transferred are to be borne by the successful bidder only and ICAR NBAIR will issue requisite certificate/ letter for the transfer of vehicles only and will have no any further financial commitment.
